Dear NSHAHS Parents, Faculty and Students,

We hope you had a meaningful start to the Yamim Noraim. Please read on for important information regarding upcoming remote learning schedules and mandatory COVID testing that affect all NSHAHS families and faculty and requires your attention and action. As always, attendance during remote learning sessions is mandatory and attendance will be taken.

Chol Hamoed Sukkot: Monday October 5th -Thursday October 8th:

Remote Learning for ALL NSHAHS STUDENTS

We will follow a regular class schedule but all classes for all students take place remotely on Zoom. There is no A/B schedule during this week. Our campus will undergo a routine deep clean during this week and no students will be allowed on campus.

Monday October 12th-Friday October 16th:

Remote Learning for ALL NSHAHS STUDENTS

Following the completion of the Chagim, out of an abundance of caution, all classes will take place remotely. We will follow a regular class schedule but all classes for all students take place remotely on Zoom. There is no A/B schedule during this week.

Mandatory COVID Testing:

Thursday, October 15th: 2:00pm-7:00pm

Friday, October 16th: 8:00am-12:00pm

In order to return to campus, all students and faculty must take a PCR nasal swab COVID test which can be done onsite during one of the two above referenced testing dates. Alternatively, students may take a PCR nasal swab test offsite and submit results to Dr. Vitow. Rapid tests will not be accepted.

We expect to receive the results from the onsite tests in time to reopen the building on Monday, October 19th. Should there be a delay in receiving the results, we will communicate with the parent and student body. **Admission back onto campus is contingent upon receiving negative test results.** Please be mindful that we will receive test results from testing done on Thursday, October 15th prior to results from testing that is done on Friday, October 16th.

We will follow a regular class schedule and all classes will take place remotely during the testing dates on October 15th-16th. Students will be excused from classes while they are at their COVID test.

Prior to arriving at COVID testing, you must complete payment and the following documentation which must be brought in hard copy to your testing:
