

ABOUT THE COURSE

The program is a complete, professionally taught Driver Education Course that will provide students with a comprehensive introduction to the driving experience. Students must complete 16 sessions of driving and 16 sessions of classroom instruction with a passing grade of 65 in each category. At the end of all 32 sessions, students will have received 24 hours of in-car driving/observation and 24 hours classroom instruction relating to the "Rules of the Road", traffic safety concerns, defensive driving, proper handling of vehicle, psychology of driving, parking and the problems of substance abuse as related to driving.

WHAT THE COURSE OFFERS

Upon completion of this course, students receive the MV-285 "Completion Certificate." This certificate entitles a 17 year old the Class D senior license when they pass the NY State DMV Road Test. Students will also receive an insurance premium reduction. **ELIGIBILITY**

Students must be 16 or 17 years old and have a N.Y. State Learner Permit to enroll in the program. The copy of the permit **must** be included **with** this Registration form.
